Early Edge California is currently seeking a Federal Policy Advisor with strong relationships in Washington, D.C. and a working knowledge of California state policy to play a key role in establishing and executing Early Edge's advocacy priorities at the federal level, specifically in Early Childhood.

Responsibilities

- Support the Early Edge team on crafting and implementing a federal policy agenda for the funding and infrastructure of a high-quality Early Learning and Care system
- Represent Early Edge to the Executive Branch and Congress, including by building relationships, meeting with key officials, legislators, and staff, gathering information, and advancing our strategic and policy goals. This role will serve as the organization's liaison to the Biden-Harris administration in addition to assisting with congressional outreach.
- Advocate with administration officials and Congress to build support for the universalization of Pre-Kindergarten and policies that support the Early Learning workforce and Dual Language Learners.
- Track and analyze federal legislation affecting early education and child care nationally and make recommended bill and policy positions to the Executive Director.
- Organize briefings and other events that educate lawmakers, the public, and the media about early education and child care and represent Early Edge with stakeholders and policymakers.
- Support the executive team and staff in developing and implementing effective legislative, administrative, and political strategies and advocacy campaigns.
- Research issues and draft testimony, presentations, policy briefs, reports, research memos, fact sheets, and other supportive materials that clearly and concisely describe complex policy options to policymakers and practitioners.
- Recruit key officials and policymakers to attend Early Edge events and help grow its national partner network.
- Support on other policy projects as needed

Qualifications

- Experience as a senior staffer or lobbyist on Capitol Hill or in the Executive Branch.
- Deep understanding of the inner workings of the Executive Branch and Capitol Hill, agency and congressional procedure, and politics.
- Successful track record of building relationships and working with both parties.

- Understanding of state, federal, and local policymaking and the role of advocacy in advancing a policy agenda.
- Experience in, or knowledge of, the California legislative process, policymaking, and advocacy.
- Creative, self-motivated, and a strong communicator capable of handling competing priorities, working collaboratively with teams across the organization and responding effectively to requests for information and technical assistance.
- Strong communications skills, including speaking, presenting, writing, listening, and ability to concisely distill and present complex information.
- Content knowledge of Early Childhood Education in higher education, training, and professional development systems and Dual Language Learners preferred.
